 - c. Persons engaged in teaching at a university or equivalent educational institutions.
 - d. Persons employed under Government of India or a state government in a class I post or in a comparable post in a public sector undertaking or an autonomous institution.
 - e. Persons holding professional qualification such as post-graduate degree or diploma in Business Management, C.A., I.C.WA., Company Secretary, M.B.B.S., B.E., or post-graduate degree in any discipline.
4. The non-profit organisations should enclose a copy of their constitution.

Notes :

- i) **THE ENTRANCE FEE PAYABLE BY A NEW INSTITUTIONAL MEMBER IS HALF OF THE YEARLY ANNUAL SUBSCRIPTION.**
