NOTE:

- 1. Any organization fulfilling criteria of institutional membership / any existing institutional member paying lump sum subscription of not less than Rs.2,25,000/- (Rupees Two Lakhs Twenty Five Thousand Only) to be decided by the Managing Committee from time to time will be termed as Patron of the Association, and will not pay any annual fee.
- 2. Plus 18% GST will be charged extra.
- 3. The first nominated representative shall be the Director or the Chief Executive or a Senior Executive of the organization. The remaining representatives should have minimum qualification applicable for professional membership i..e. they must be.
 - a. Directors, Proprietor or working partner of a company, firm or establishment
 - b. Senior executives in general management cadre or functional executives who have held responsible position
 - c. Persons engaged in teaching at a University or equivalent educational institutions
 - d. Persons employed under Government of India or a state government in a class 1 post or in a comparable post in a public sector undertaking or an autonomous institution
 - e. Persons holding professional qualification such as post-graduate degree or diploma in Business Management, C.A., I.C.W.A., Company Secretary, M.B.B.S., B.E., or post-graduate degree in any discipline.
- 4. The Non-Profit organizations should enclose a copy of their constitution.
