ELIGIBILITY CRITERIA

PROFESSIONAL MEMBERS:

The following categories of persons subscribing to the objects of the Association shall be eligible for professional membership:

- a) Directors, Proprietor or working partners of a company, firm or establishment.
- b) Senior executive in general management cadre or functional executives who have held responsible positions.
- c) Persons engaged in teaching at a university or equivalent educational institutions.
- d) Persons employed under Government of India or a state government in class I post or in a comparable post in a public sector undertaking or an autonomous institution.
- e) Persons holding professional qualifications such as post graduate degree or diploma in Business Management, CA, I.C.W.A., Company Secretary, a recognized degree in Engineering /Technology or any system of medicine or post graduate degree in any discipline, who have completed not less than five years after obtaining the first professional or post graduate degree.
- f) On payment of a lump sum of ₹ 25,000/- (Rupees Twenty Five Thousand only) a person is eligible for life membership of the Association.

ASSOCIATE MEMBERS:

All the persons below 35 years in age, who are interested in management movement but who do not qualify for professional membership shall be eligible to become Associate Members. An Associate Member, as soon as he attains the qualifications and experience for professional membership, may apply to become a professional member. A person shall cease to be an Associate Member on attaining age of 35 years.

STUDENT MEMBERS:

Individuals who are pursuing their studies in a recognised institution will be eligible to become student members.

- 1. LIFE MEMBER IS NOT REQUIRED TO PAYENTRANCE FEE.
- 2. Annual subscription for a new member applying after 30th September shall be 50% of the normal annual subscription, but entrance fee shall be payable in full.
- 3. After the application has been scrutinised and approved by the BMA Managing Committee the applicant will be intimated the membership number and date of admission,
- 4. In case of Senior Citizens, new Professional Membership Fees will be applied while considering the 50% concession. (Members above the age of 65 yrs are eligible)
- 5. Plus 18% GST will be charged extra.
